

Economic Development and Diversification: Tribally-Owned Non-Gaming Hotels – 2016

As of July 1, 2016, there were 46 non-gaming triballyowned hotels in thirteen different states and the District of Columbia. Combined, these properties have an estimated 7,000 rooms and almost 500,000 sq. ft. of meeting space. This information is presented in the table on the following page.

These hotel properties have been acquired in a variety of ways. In some cases, tribes owned and operated hotel properties prior to gaming, or they are existing hotels purchased by individual tribes. In other cases, they are new built properties by individual tribes. In several cases, groups of Indian tribes have formed consortiums to develop hotel properties. In all cases, non-gaming hotels have enabled tribes to diversify their economies both on and off the reservation. The following are some examples.

The Confederated Tribes of Warm Springs in Oregon has owned and operated its successful 170-unit Ka-Nee-Ta Resort & Spa for decades, years before gaming came to the reservation.

The 56-unit Quality Inn Navajo Nation Capital in Window Rock, AZ (formerly the Navajo Nation Inn) was owned and operated by the Navajo Nation Hospitality Enterprise of the Navajo Nation, even before gaming. The same is true with the 353-unit Radisson Hotel & Conference Center Green Bay owned by the Oneida Nation of Wisconsin, which developed and operated the property before any gaming development at the location.

The Mille Lacs Band of Ojibwe, through its Mille Lacs Corporate Ventures, has acquired and operates three hotel properties in the Twin Cities, two resorts in greater Minnesota and even an all-suite hotel property in Oklahoma City. In addition to purchasing the properties, the Mille Lacs Band has re-invested millions in the improvement and renovation of its properties - most notably of which is the InterContinental Saint Paul Riverfront Hotel. Purchased in 2013, the Crowne Plaza Riverfront was completely renovated and upgraded and opened in October 2015 as the InterContinental Saint Paul Riverfront – the first InterContinental property in the region.

In addition to purchasing and completely renovating the historic U.S. Grant Hotel in San Diego, the Sycuan Band of the Kumeyaay Nation became partners with MRW Group and Latino Builders to form the Marina Gateway Company, which developed a 173-room Best Western Plus hotel, restaurant and commercial building to revitalize the National City waterfront from industrial to recreational and retail. The Salt River Pima-Maricopa Indian Community built, own and operate its 153-unit Courtyard by Marriott Scottsdale Salt River. In addition, the Shakopee Mdewakanton Sioux Community recently completed construction of its 342-unit JW Marriott Minneapolis Mall of America property.

Four Fires, a consortium of the Oneida Nation of Wisconsin, San Manuel Band of Mission Indians, Viejas Band of Kumeyaay Indians and Forest County Potawatomi Community developed and own the 202-unit Residence Inn Downtown Washington D.C. Similarly, Three Fires, a consortium of the Oneida Nation of Wisconsin, San Manuel Band of Mission Indians and the Viejas Band of Kumeyaay Indians developed and own the 239-unit Residence Inn Sacramento at Capitol Park in California. Perhaps most noteworthy with respect to tribal consortiums, all 19 Pueblos of New Mexico developed and own the 108-unit Holiday Inn Express & Suites Albuquerque Historic Old Town, located immediately across the street from the Indian Pueblo Cultural Center.

With respect to quality, the tribally-owned non-gaming hotels range in quality from small inns to first class destination properties. The Automobile Association of America (AAA) utilizes a diamond rating with one being the lowest and five

being the highest. Of the 46 non-gaming hotel properties owned by gaming tribes, 26 have been reviewed by AAA of which seven are four-diamond properties, seventeen are threediamond properties and two are two-diamond properties with an overall average rating of 3.2 diamonds.

As previously discussed, non-gaming hotels have enabled tribes to diversify their economies both on and off the reservation. The business of gaming is hospitality. The business of hotels is hospitality. Instead of a gaming tribe diving into uncharted waters in the name of economic development and diversification, bombarded on a daily basis with a myriad of "can't lose" business opportunities with which the tribe has zero experience in the ownership and/or operation of – "do what you know." Hospitality, hospitality, hospitality. In addition to hotels, there are a variety of other businesses with which a gaming tribe can "internalize the externalities" (i.e. lateral purchases of goods and services enterprises). These successfully, depending on the tribe, have included food and beverage products, advertising, marketing, promotion and printing companies, travel agencies, construction, development and consulting firms, and banking and financial institutions.
